One of the newest services offered by ANTA is a private car registration with its own private registration number that has been activated in the system. The BENEFITS of having this private registration, is that you have a registration to show any officer who asks for one and that everything is beautifully pulled together on the private side. Before you can obtain this registration, you first must have the ANPC private traveller card, the ANTA international travel permit (IDP), your car in a foreign trust, and your voters registration and state driver's license cancelled using the cancellation letters on www.americannationals.org. Find below the steps that have been put in place to help you have freedom of travel. ANTA's top priority is to have you travel SAFELY without harassment and these steps together have been proven by many to do just that.

STEP 1: Cancel your voter's registration in the last county you voted by mailing the cancellation letter by certified mail. (If you never registered, then skip this step.) KEEP COPIES OF EVERYTHING! Forward a scan of your cancellation letter and certified mail number to anpcorders@gmail.com so ANTA can verify that this is completed.

STEP 2: PERFECT YOUR TITLE if you ever had a Birth Certificate. (Perfected Title Pkg) (if you never had one, this step does not apply).

STEP 3: Order the ANPC Foreign Drivers License and ANTA International Driving permit.

STEP 4: Order your Foreign trusts (98 & 83) and place your car in it per instructions you receive with your trust. To Order, email anpcorders@gmail.com

STEP 5: Order a Private non-UCC lien, private bond self-insurance (if you choose that type of insurance) and Private tags through www.americannationals.org

STEP 6: Now, you may Order your ANTA Private car registration by emailing the following completed order page to: anpcorders@gmail.com

STEP 7: Cancel your state driver's license if you have one.
