We suggest the 1st 98 TR be done in your BIRTH NAME which is the CREATOR for the Simple #83 series Trusts holding your assets, they are in the PUBLIC. If you want extra protection OR have done a Name change and have a different name than is on your Birth Certificate, then you will want to layer a second 98 trust under the first using your new name or creating another name.

You will receive all the TRUST documents by email and the CP575 delivery of the 98 Trust by USPS Mail will take approximately 4-6 weeks from the IRS.

DEFINITIONS OF TRUST POSITIONS

TRUSTEE: The person appointed, or required by law, to execute a trust; one in whom an estate, interest, or power is vested, under an express or implied agreement to administer or exercise it for the benefit. (Usually use a variation of your Upper/Lowercase "Name" Here. i.e: John Ray Doe or John R. Doe---this is not your Living Man.)

CREATOR: The originator of the TRUST, appoints the TRUSTEE, SETTLOR & SUCCESSOR TRUSTEES. (This will be either Another 98 Trust OR a Variation of your Upper Lowercase Name again i.e. John Doe or INFINITY TRUST etc)

SETTLOR: The grantor or donor in a deed of settlement, oversees the trust, even though in form the trust is created by another. (THIS IS SAME AS TRUSTEE)

SUCCESSOR TRUSTEE: A person that will assume TRUSTEE position when main TRUSTEE dies or resigns.



VERY IMPORTANT NOTE!!! You CANNOT use a trust mailing address that is tied to your name in any way through banking, Post Office, IRS, Social Security, old driver's License etc. You can use a friend or family members address OR get a new PO Box WITHOUT A SSN using your ID, IDP etc.
